VI. WORKSHOP DISCUSSION ITEMS - Chief School Administrator, Seth Cohen

- **OPERATIONS** Mr. Cohen discussed graduation, awards ceremony and the 8th grade clap-out. He also reviewed student discipline issues.
- **PERSONNEL** The CSA evaluation needs to completed as soon as possible and an additional meeting might be warranted for approval. Mr. Cohen mentioned an issue with the doctorate program payment and will discuss with the Board in detail in the near future.
- **TECHNOLOGY** Mr. Cohen said that the 8th graders will be taking their chromebooks upon graduation. The school is currently at a 1:1 with student chromebooks and are working on achieving this ratio with the teaching staff.
- **FACILITIES** Mr. Cohen said the building's façade is cracking and in need of repair soon before any further problems occur. He told the Board that the district would be receiving an assessment and survey for the JCP&L Grant this fall. An assessment of the full facility needs to be done by USA Architects who quoted approximately \$22K for the work. The district is considering other options.

VII. NEW BUSINESS – Mr. Cohen said that he was looking for a CST partner. He reported that 16 kindergarteners have already registered.
